### LETTER OF UNDERSTANDING

### In respect of the Surrey Langley SkyTrain Project

This **LETTER OF UNDERSTANDING** is entered into as of the 4<sup>th</sup> day of August, 2022

### **BETWEEN:**

BC INFRASTRUCTURE BENEFITS INC.

### AND:

### ALLIED INFRASTRUCTURE AND RELATED CONSTRUCTION COUNCIL OF BRITISH COLUMBIA

### **WHEREAS:**

- A. The parties entered into a Community Benefits Agreement dated the 17<sup>th</sup> day of July, 2018, as amended and restated on March 1, 2022, as may be further amended, supplemented or restated from time to time (the "Community Benefits Agreement") which governs the terms and conditions of employment for Employees in respect of the Projects;
- B. The Community Benefits Agreement contemplates that additional Projects may be added to the Community Benefits Agreement upon agreement between the Employer and the Council; and
- C. The parties wish to formally recognize the Surrey Langley SkyTrain Project as a Community Benefits Agreement Project, and to include within the Community Benefits Agreement an Appendix entitled "Project Definition: Surrey Langley SkyTrain Project".

**NOW, THEREFORE,** for good and valuable consideration, the receipt and sufficiency of which are hereby irrevocably acknowledged by each party, the parties agree as follows:

- 1. All capitalized terms used in this Letter of Understanding but not defined in this Letter of Understanding have the meanings given to those terms in the Community Benefits Agreement.
- 2. The document attached as Schedule 1 to this Letter of Understanding entitled "PROJECT DEFINITION: SURREY LANGLEY SKYTRAIN PROJECT" shall form an Appendix to the Community Benefits Agreement.
- 3. This Letter of Understanding shall be governed by and construed in accordance with the laws of the Province of British Columbia and the federal laws of Canada applicable in British Columbia.
- 4. This Letter of Understanding may be executed by counterparts, each of which will be deemed to be an original and all of which taken together will be deemed to constitute one

and the same instrument. Delivery by email in portable document format (PDF) of an executed counterpart of this Letter of Understanding is as effective as delivery of an originally executed counterpart of this Letter of Understanding.

### SCHEDULE 1 PROJECT DEFINITION: SURREY LANGLEY SKYTRAIN PROJECT

(see attached)

**Project Name:** Surrey Langley SkyTrain Project (for the purposes of this Project Definition Appendix, this "**Project**").

**Owner:** The "Owner" pursuant to Master Section Article 2.317, is Transportation Investment Corporation on behalf of the BC Transportation Financing Authority.

**Location:** This Project will extend the existing Expo Line SkyTrain system by 16km from its current terminus at King George Station in the City of Surrey, through the Township of Langley, to a new terminus at Langley City Centre. Figure 1 below shows the proposed Project alignment.



**Project Description:** Construction of a 16km SkyTrain extension from the existing King George Station along an elevated guideway with eight new stations to a new terminus at Langley City Centre.

This Project includes:

- elevated guideway;
- eight new stations;
- roadwork, including widening and modifications;
- construction of three new transit exchanges and provision for parking; and
- installation of track work and traction power.

**Scope of Work:** The work to be performed under the terms of the Community Benefits Agreement with respect to the components set out in the Project Description above is set out in Schedule "A" attached hereto. Work that is excluded from the scope of the Community Benefits Agreement is set out in Schedule "B" attached hereto. The actual scope of work may vary as it will encompass the final design prepared by the contractor(s).

**Modifications to Community Benefits Agreement for this Project:** The following modifications are made to the Community Benefits Agreement only for and only in respect of this Project:

- (a) Article 2.309(i) of the Community Benefits Agreement is modified to read as follows:
  - "(i) Persons and firms performing relocation work for municipal sewer and water works and utility companies (e.g. telecommunications and internet, natural gas supply, cable T.V. companies, electric power lines, etc.), and any other work on Site for utility companies and municipal works, and persons or firms performing work for or engaged by TransLink (including its subsidiaries), Thales, Ministry of Transportation and Infrastructure, Transportation Investment Corporation, City of Surrey, City of Langley, Township of Langley and Technical Safety BC."
- (b) Notwithstanding anything to the contrary contained in Article 8.600 of the Community Benefits Agreement, with respect to the crew working in conjunction with the operation of any segmental erection truss, including truss moving, erecting and dismantling:
  - 1. the operator(s) of each segmental erection truss shall not be an Employee; and
  - 2. the Employer shall have the right, for itself and each Contractor, to hire as follows:
    - (i) name request from the Affiliated Union each other member of the crew; and
    - (ii) in the case where such name requested individual(s) is not available, 'name hire' any other required member of the crew,

provided that such name requests and/or name hires have all certifications required by the segmental erection truss owner.

- (c) Each operator of a segmental erection truss shall be paid at CBA wage rates for comparable work, at a minimum.
- (d) Upon identification of a Contractor who will be operating a segmental erection truss, a business representative of the AIRCC and the International Association of Bridge, Structural, Ornamental and Reinforcing Ironworkers Local Union 97 shall meet with the Employer and such Contractor to discuss crew requirements for the segmental erection truss and the potential name requests that will be made. The business representatives shall make reasonable efforts to ensure that such individuals are available to be hired on this Project.

(e) The Parties acknowledge that during this Project's procurement, a proponent may request a provision for additional name requests and/or name hires and will endeavor to respond to such requests within 72 hours.

In the event of any conflict between the above provisions and any other provision, express or implied, in the remainder of the Agreement, the above provisions shall take precedence.

### Schedule "A"

### **Work Included In Scope Of Community Benefits Agreement**

- 1. Site preparation including demolition, worksite set-up and pick-up of embankment material
- 2. Roads, including bus exchanges and active transportation except for any work carried out by the City of Surrey, the City of Langley or the Township of Langley
- 3. Traffic Management (excluding work covered by the City of Surrey, the City of Langley and Township of Langley)
- 4. Station structure including site preparation, excavation, support of excavation and platform structures
- 5. Elevated guideway, similar to existing rail transit
- 6. Station fit-out including finishes, fittings, electrical, mechanical and stationhouse structure
- 7. Track work and Linear Induction Motor (LIM) rail
- 8. Electrical and Power Systems including installation of power rail, feeder cables and duct bank and sub-stations
- 9. Propulsion Power Sub-Stations
- 10. Casting Yard (if purpose-built)

### Schedule "B"

### **Work Excluded From Scope Of Community Benefits Agreement**

- 1. BC Rapid Transit Company support during implementation including testing and commissioning activities
- 2. TransLink Faregate Installation and supporting equipment (such as fare vending machines/fare add cards) installation (but not construction work that supports such equipment)
- 3. Automatic Train Control (ATC) Control of train movement, including additional head-end hardware at the Control Centre, up-dating and additional software to operate the extension
- 4. Conveyance works, such as elevator and escalator installation (but not construction work that supports such equipment)
- 5. Architectural and design work performed by those individuals employed in a professional capacity
- 6. Casting Yard (if an existing facility is used)
- 7. Utility relocations
- 8. Specialized systems works, including radio, camera, communications installations (but not construction work that supports such systems
- 9. Public art installation (but not construction work that supports such art)
